## INFORMATION ABOUT MEMBERSHIP

As a member of YTK, you will receive support and security during changes in your working life. If you meet the working conditions during your membership, you can apply for earnings-related daily allowance from us. You can also apply for mobility assistance, change security allowance, and job alternation compensation.

You can join the unemployment fund when you are in paid employment. We do not have any occupational restrictions on membership, so you can join us regardless of your field or profession. We can provide you with income security throughout your career, even if you change fields.

Once you are a member, remember to keep your membership valid. You can do this by paying your membership fee. You will receive your first membership fee invoice once we have approved your membership application. After this, we will send you a membership fee invoice once a year. For more information about membership fees, visit ytkkassa.fi/en/membership

Entitlement to earnings-related daily allowance requires that you meet the membership and working conditions. The membership condition is met if you have been a member of an unemployment fund for at least 12 months prior to becoming unemployed. The working requirement is met when you have accumulated 12 months of employment during your membership. You can apply for membership of the YTK Unemployment Fund using the membership form. Write clearly and answer every question. Remember to sign your application. The membership form can also be easily filled out online at ytkkassa.fi/en. If your application meets the membership requirements, your membership will begin on the date the membership form is received, at the earliest.
